RESOLUTION NO. 3-93-22

RESCINDING RESOLUTION NO. 3-80-22

AND RE-ESTABLISHING WARDS AND POLLING PLACES

WHEREAS, the legislature of the State of Minnesota has been redistricted; and

WHEREAS, Minnesota Statute Section 204B.14, subd. 3(d) requires that ward boundaries must be established within 60 days of when the legislature has been redistricted or at least 19 weeks before the state primary election, whichever comes first, and

WHEREAS, Resolution No. 3-80-22, Establishing Wards and Polling Places was adopted by the City Council on March 14, 2022, and

WHEREAS, after the resolution was certified, it was determined that incorrect Census data was used to create the ward boundaries and polling places established by Resolution No. 3-80-22; and

WHEREAS, the City Clerk recommends that Resolution No. 3-80-22 be rescinded; and the wards and polling places for the City of Two Harbors be re-established, now therefore

BE IT RESOLVED, that the City Council of the City of Two Harbors, County of Lake, State of Minnesota hereby rescinds Resolution No. 3-80-22 and establishes the boundaries of the voting wards and polling places in the City of Two Harbors, Minnesota as follows:

WARD 1 (Community Center, 517 South Avenue)

That part of the city lying at the intersection of the westerly boundary of the parcel identified as 23-7600-01415 and the shoreline of Lake Superior, then heading north and west along said property line to Waterfront Drive (Sixth Street), then north to the alley south of First Avenue in the 600 block and west to Seventh Street; then north along Seventh Street to the alley between Fifth and Sixth Avenue, then east to Fifth Street, then north to Highway 61 (Seventh Avenue). From there, extending north-east along the south side of Highway 61 (Seventh Avenue) to Burlington Road where it heads east to the City limit line and then south to the shore of Lake Superior, which provides the entire southerly border of the ward.

WARD 2 (Community Center, 517 South Avenue)

That part of the City extending from where the western border of a parcel identified as 23-7600-01430 intersects with the southern City limit line and the CN railroad tracks, following the southeast set of railroad tracks north and east to Highway 61 (Seventh Avenue), then east to Ninth Street and north to the alley between Ninth and Tenth Avenues, then East to Seventh Street and north along Seventh Street to Tenth Avenue, then east along Tenth Avenue to Highway 2 (Fourth Street), then south to Highway 61 (Seventh Avenue), and west to Fifth Street, then south to the alley between Fourth and Fifth Avenues and west to Seventh Street, then south to the alley south of First Avenue and east to Waterfront Drive; then south to South Avenue and continuing south following the boundary of the parcel identified as 23-7600-01415; then west along the shoreline of Lake Superior to the westerly boundary of the parcel identified as 23-7600-01801.

WARD 3 (Community Center, 517 South Avenue)

That part of the City lying east of Ninth Street from the alley between Ninth and Tenth Avenues north to Thirteenth Avenue then east to Eighth Street and north to Fourteenth Avenue; then west to Tenth Street and north to Sixteenth Avenue, then east to Sixth Street and north to the alley between Sixteenth and Seventeenth Avenue, then east to Highway 2 (Fourth Street) then north to Fairgrounds Road and east along the northern City limit line to where it meets the east city limit line and south along the east City limit line to Highway 61 (Seventh Avenue); then west along Highway 61 (Seventh Street) to Highway 2 and north at Highway 2 to Tenth Avenue; then west

along Tenth Avenue to Seventh Street; then south to the alley between Ninth and Tenth Avenues and west to Ninth Street.

WARD 4 (Community Center, 517 South Avenue)

That part of the City extending from where the west City Limit Line meets the south City Limit Line north along the west City Limit Line to the North City Limit Line at Twentieth Avenue; from the north City limit line across Twentieth Avenue east to Highway 2, then south along Highway 2 to the alley between Sixteenth and Seventeenth Avenues, then west to Sixth Street and South to Sixteenth Avenue; then west to Tenth Street, then south to Fourteenth Avenue and east to Eighth Street; then south to Thirteenth Avenue and west to Ninth street; then south to Highway 61 (Seventh Avenue); then west to the railway tracks then south along the railroad tracks to where the railroad tracks meet a parcel identified as 23-7600-01801; then south to the southerly city limit line; then west along the southerly city limit line to the westerly city limit line.
