RESOLUTION NO. 2022 - 56

A RESOLUTION ESTABLISHING PRECINCT BOUNDARIES AND POLLING PLACES FOR ELECTIONS

WHEREAS, the City Council of the City of Bloomington is the official governing body of the City of Bloomington, Minnesota; and

WHEREAS, the legislature of the State of Minnesota has been redistricted; and

WHEREAS, the City Council, as the official governing body, is required by Minnesota Statutes, Section 204B.14 to reestablish precinct boundaries and polling place locations following decennial redistricting of legislative boundaries; and

WHEREAS, the City Council has determined after a review of the precinct boundaries and polling places presented to it by the City Clerk that said boundaries and polling places meet the requirements necessary for precincts and polling places.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BLOOMINGTON, MINNESOTA that the following precinct numbers, polling place locations and descriptions of precinct boundaries are hereby approved and effective beginning with the August 9, 2022 Primary:

Precinct 1

Polling Location: Atonement Lutheran Church, 601 East Old Shakopee Road **Description:** Beginning at the intersection of Minnesota State Highway 77 and 86th Street East; southerly along Minnesota State Highway 77 to the municipal boundary of the City of Bloomington; southwesterly along southern municipal boundary to the Northern States Power Company power lines; northwesterly along the Northern States Power Company power lines to Park Avenue South; northerly along Park Avenue South to 103rd Street East; westerly along 103rd Street East to Portland Avenue South; northerly along Portland Avenue South to 98th Street East; easterly along 98th Street East to East Old Shakopee Road; northeasterly along East Old Shakopee Road to Old Cedar Avenue South; northerly on Old Cedar Avenue South to 86th Street East; easterly along 86th Street East to the point of beginning.

along 102nd Street East to Nicollet Avenue South; northerly along Nicollet Avenue South to 98th Street East; easterly along 98th Street East to the point of beginning.

Precinct 3

Polling Location: St. Luke's Lutheran Church, 1701 West Old Shakopee Road **Description:** Beginning at the intersection of 98th Street West and Nicollet Avenue South; southerly along Nicollet Avenue South to 102nd Street West; westerly along 102nd Street West to Lyndale Avenue South; southerly along Lyndale Avenue South to 106th Street West; westerly along 106th Street West to Bloomington Freeway West; northerly along Bloomington Freeway West to 102nd Street West; westerly along 102nd Street West to Fremont Avenue South; northerly along Freemont Avenue South to 100th Street West; westerly along 100th Street West to West Old Shakopee Road; southwesterly along West Old Shakopee Road to Penn Avenue South; northerly along Penn Avenue South to 98th Street West; easterly along 98th Street West to the point of beginning.

Precinct 4

Polling Location: Oak Grove Presbyterian Church, 2200 West Old Shakopee Road **Description:** Beginning at the intersection of 102nd Street West and Bloomington Freeway West; southerly along Bloomington Freeway West to 106th Street West; easterly along 106th Street West to Interstate Highway 35W; southerly along Interstate Highway 35W to the municipal boundary; westerly along the municipal boundary to Nine Mile Creek; northerly and westerly along Nine Mile Creek to 106th Street West; westerly along 106th Street West to Sheridan Avenue South; northerly along Sheridan Avenue South to West Old Shakopee Road; northeasterly along West Old Shakopee Road to 100th Street West; easterly along 100th Street West to Fremont Avenue South; southerly along Fremont Avenue South to 102nd Street West; easterly along 102nd Street West to the point of beginning.

Precinct 5

Polling Location: Minnesota Valley Unitarian Universalist Fellowship, 10715 Zenith Ave South **Description:** Beginning at the intersection of Nine Mile Creek and 106th Street West; southerly and easterly along Nine Mile Creek to the southern municipal boundary; southwesterly along southern municipal boundary to the west line of the Southwest Quarter of Section 29, Township 27, Range 24, Hennepin County, Minnesota; northerly along west line to Irwin Avenue South; northerly along Irwin Avenue South to Overlook Drive; easterly along Overlook Drive to France Avenue South; northerly along France Avenue South to 114th Street West; easterly along 114th Street West to Ewing Avenue South; northerly along Ewing Avenue South to 112th Street West; easterly along 110th Street West to Drew Avenue South; northerly along Xerxes Avenue South to West Old Shakopee Road; northeasterly along West Old Shakopee Road to Sheridan Avenue South; southerly along Sheridan Avenue South to 106th Street West; easterly along 106th Street West to the point of beginning.

Polling Location: Bloomington Covenant Church, 10150 Xerxes Ave South Description: Beginning at the intersection of 102nd Street West and France Avenue South; southerly along France Avenue South to West Old Shakopee Road; westerly along West Old Shakopee Road to Nesbitt Avenue South; northerly along Nesbitt Avenue South to 102nd Street West; easterly along 102nd Street West to the point of beginning.

Precinct 9

Polling Location: Transfiguration Lutheran Church, 11000 France Ave South **Description:** Beginning at the intersection of West Old Shakopee Road and France Avenue South; southerly along France Avenue south to 109th Street West; easterly along 109th Street West to Drew Avenue South; southerly along Drew Avenue South to 112th Street West; westerly along 112th Street West to Ewing Avenue South; southerly along Ewing Avenue South to 114th Street West; westerly along 114th Street West to France Avenue South; southerly along France Avenue South to Overlook Drive; westerly and northerly along Overlook Drive to Normandale Boulevard; northerly along Normandale Boulevard to West Old Shakopee Road; easterly along West Old Shakopee Road to the point of beginning.

Polling Location: Minnesota Masonic Heritage Center, 11411 Masonic Home Drive **Description:** Beginning at the intersection of Overlook Drive and Irwin Avenue South; southerly along Irwin Avenue South to the west line of the Southwest Quarter of Section 29, Township 27, Range 24, Hennepin County, Minnesota; southerly along the west line to the southern municipal boundary; southwesterly along the southern municipal boundary to the Bloomington Ferry Trailhead pedestrian bridge; northerly along the Bloomington Ferry Trailhead pedestrian bridge to Bloomington Ferry Road; easterly along Bloomington Ferry Road to Auto Club Road; easterly along Auto Club Road to 114th Street West; easterly along 114th Street West to 114th Street Circle West; southeasterly along 114th Street Circle West to Minnesota Bluffs Drive; northerly along Minnesota Bluffs Drive to Oregon Avenue South; northeasterly along Oregon Avenue South to Bush Lake Road; northerly along Bush Lake Road to West Old Shakopee Road; easterly along West Old Shakopee Road to Normandale Boulevard; southerly along Normandale Boulevard to Overlook Drive; easterly and southerly along Overlook Drive to the point of beginning.

Precinct 12

Polling Location: Community of the Cross Lutheran Church, 10701 Bloomington Ferry Road **Description:** Beginning at the intersection of East Bush Lake Road and the Soo Line Railroad Company railroad tracks; southerly along the Soo Line Railroad Company railroad tracks; southerly along West Old Shakopee Road to Bloomington Ferry Road; northerly along Bloomington Ferry Road to 102nd Street West; northeasterly along 102nd Street West to Utah Avenue South; northerly along Utah Avenue South to 100th Street West; easterly along 101st Street West to Bush Lake Road; northerly along 101st Street West to Bush Lake Road; northerly along 101st Street West to Bush Lake Road; northerly along 101st Street West to Bush Lake Road; northerly along Bush Lake Road to East Bush Lake Road; northerly and easterly along East Bush Lake Road to the point of beginning.

Description: Beginning at the intersection of West Old Shakopee Road and Bush Lake Road; southerly along Bush Lake Road to Oregon Avenue South; southwesterly along Oregon Avenue South to Minnesota Bluffs Drive; southeasterly along Minnesota Bluffs Drive to 114th Street Circle West; westerly along 114th Street Circle West to 114th Street West; westerly along 114th Street West to Auto Club Road; westerly along Auto Club Road to Bloomington Ferry Road; westerly along Bloomington Ferry Road to the Bloomington Ferry Trailhead pedestrian bridge; southerly on the Bloomington Ferry Trailhead pedestrian bridge to the southern municipal boundary; westerly along the southern municipal boundary to West Old Shakopee Road; easterly along West Old Shakopee Road to the point of beginning.

Precinct 14

Polling Location: Bloomington Lutheran School, 10600 Bloomington Ferry Road **Description:** Beginning at the intersection of Lindstrom Drive and Bush Lake Road; southerly along Bush Lake Road to 101st Street West; westerly along 101st Street West to Quebec Avenue South; northerly along Quebec Avenue South to 100th Street West; westerly along 100th Street West to Utah Avenue South; southerly along Utah Avenue South to 102nd Street West; southwesterly along 102nd Street West to Bloomington Ferry Road; southerly along Bloomington Ferry Road to West Old Shakopee Road; westerly along West Old Shakopee Road to the western municipal boundary; northerly along the western municipal boundary to Pioneer Trail; easterly along Pioneer Trial to Bloomington Ferry Road; northerly along Bloomington Ferry Road to Lindstrom Drive; easterly along Lindstrom Drive to the point of beginning.

Polling Location: Bloomington City Hall, 1800 West Old Shakopee Road **Description:** Beginning at the intersection of the northern municipal boundary and Interstate Highway 35W; southerly along Interstate Highway 35W South to 98th Street West; westerly along 98th Street West to Penn Avenue South; northerly along Penn Avenue South to the northern municipal boundary; easterly along the northern municipal boundary to the point of beginning.

Precinct 24

Polling Location: Christ the King Lutheran Church, 8600 Fremont Ave South **Description:** Beginning at the intersection of the northern municipal boundary and Lyndale Avenue South; southerly along Lyndale Avenue South to 90th Street West; westerly along 90th

Street West to Interstate Highway 35W; northerly along Interstate Highway 35W to the northern municipal boundary; easterly along the northern municipal boundary to the point of beginning.

Precinct 25

Precinct 26

Polling Location: Bloomington Lutheran Church, 9350 Portland Ave South **Description:** Beginning at the intersection of 92nd Street East and 10th Avenue South; southerly along 10th Avenue South to 94th Street East; easterly along 94th Street East to Riverview Avenue South; southeast along Riverview Avenue South to East Old Shakopee Road; southwesterly along East Old Shakopee Road to 98th Street East; westerly along 98th Street East to Nicollet Avenue South; northerly along Nicollet Avenue South to 92nd Street East; easterly along 92nd Street East to the point of beginning.

Precinct 27

Description: Beginning at the intersection of the northern municipal boundary and Portland Avenue South; southerly along Portland Avenue South to 86th Street East; westerly along 86th Street East to 86th Street West; westerly along 86th Street West to Lyndale Avenue South; northerly along Lyndale Avenue South to the northern municipal boundary; easterly along the northern municipal boundary to the point of beginning.

Precinct 29

Polling Location: Portland Ave United Methodist Church, 8000 Portland Ave South **Description:** Beginning at the intersection of the northern municipal boundary and Minnesota State Highway 77; southerly along Minnesota State Highway 77 to 84th Street East; westerly along 84th Street East to Bloomington Avenue South; southerly along Bloomington Avenue South to 86th Street East; westerly along 86th Street East to Portland Avenue South; northerly along Portland Avenue South to the northern municipal boundary; easterly along the northern municipal boundary to the point of beginning.

Precinct 30

Polling Location: Cedar Valley Church, 8600 Bloomington Ave South **Description:** Beginning at the intersection of Killebrew Drive and East Old Shakopee Road; southerly along East Old Shakopee Road to 86th Street East; westerly along 86th Street East to Old Cedar Avenue; southerly along Old Cedar Avenue to East Old Shakopee Road; southwesterly along East Old Shakopee Road to Riverview Avenue South; northerly along Riverview Avenue South to 94th Street East; westerly along 94th Street East to 10th Avenue South; northerly along 10th Avenue South to 86th Street East; easterly along 86th Street East to Bloomington Avenue South; northerly along Bloomington Avenue South to 84th Street East; easterly along 84th Street East to Minnesota State Highway 77; northerly along Minnesota State Highway 77 to Killebrew Drive; easterly along Killebrew Drive to the point of beginning.

Precinct 31

Polling Location: MN Valley National Wildlife Refuge Building, 3815 American Blvd East **Description:** Beginning at the intersection of the northern municipal boundary and the eastern municipal boundary; southerly along the eastern municipal boundary to Minnesota State Highway 77; northerly along Minnesota State Highway 77 to 86th Street East; easterly along 86th Street East to East Old Shakopee Road; northerly along East Old Shakopee Road to Killebrew Drive; westerly along Killebrew Drive to Minnesota State Highway 77; northerly along municipal boundary; easterly along the northern municipal boundary; easterly along the northern municipal boundary to the point of beginning.
