## RESOLUTION ESTABLISHING PRECINCT AND POLLING LOCATIONS FOR 2022 ELECTION YEAR

WHEREAS, the Legislature of the State of Minnesota has been redistricted and
WHEREAS, the City Council of the City of Ramsey has reestablished the City's Ward line boundaries by Ordinance and

WHEREAS, the voting precincts in the City must be reestablished after the Legislature has been redistricted.

## NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF RAMSEY, ANOKA COUNTY, STATE OF MINNESOTA, as follows:

1) That the City of Ramsey is divided into four wards and nine precincts effective with the August 9, 2022 State Primary Election.
2) That the boundaries of the precincts are hereby established pursuant to Minnesota Statute 204.B14, subdivision 3c.
3) That the polling places of the precincts are hereby established pursuant to Minnesota Statute 204.B16.
4) That such boundaries and polling places shall be as follows:

Thence southeast along Nowthen Boulevard NW (CSAH 5) to the intersection of Azurite Street NW and Nowthen Boulevard NW (CSAH \#5). Thence following Azurite Street NW northeast to the intersection of $162^{\text {nd }}$ Avenue NW and Azurite Street NW. Thence following $162^{\text {nd }}$ Avenue NW northeast to the intersection of Yttrium Street NW and $162^{\text {nd }}$ Avenue NW. Thence following Yttrium Street NW north to the intersection of $167^{\text {th }}$ Avenue NW and Yttrium Street NW. Thence following $167^{\text {th }}$ Avenue NW west to the intersection of Nowthen Boulevard NW (CSAH \#5) and $167^{\text {th }}$ Avenue NW. Thence following Nowthen Boulevard NW (CSAH \#5) north to the point of beginning.

Thence following $142^{\text {nd }}$ Lane NW easterly to the intersection of Tungsten Way NW and $142^{\text {nd }}$ Lane NW. Thence following Tungsten Way NW/ Tungsten Street NW northerly to the intersection of $145^{\text {th }}$ Lane NW and Tungsten Street NW. Thence following along $145^{\text {th }}$ Lane NW westerly to the intersection of Sunwood Drive NW and $145^{\text {th }}$ Lane NW. Thence following along Sunwood Drive NW westerly to the intersection of Sunfish Lake Boulevard NW (CSAH \#57) and Sunwood Drive NW. Thence Sunfish Lake Boulevard NW (CSAH \#57) north to the intersection of Sunfish Lake Boulevard NW (CSAH \#57) and Alpine Drive NW, the point of beginning.

Polling Place: Ramsey Fire Station No. 2, 5650 Alpine Drive NW

## Ward 4 Precinct 2:

Boundary: Beginning at the intersection of Nowthen Boulevard NW (CSAH \#5) and Alpine Drive NW. Thence easterly along Alpine Drive NW to the intersection of Roanoke Street NW and Alpine Drive NW. Thence following Roanoke Street NW north to the intersection of Juniper Ridge Drive NW and Roanoke Street NW. Thence northerly along the east property line of Lot 11, Block 1, of Reilley Estates (said property address 15637 Juniper Ridge Drive NW) to the eastern City limits (Rum River). Thence following the Rum River downstream along the eastern City limits to the southern City limits. Thence following the Southern City limits west to St. Francis Boulevard (State Highway \#47). Thence following St. Francis Boulevard (State Highway \#47) north to the intersection of Nowthen Boulevard NW (CSAH \#5) and (State Highway \#47). Thence following Nowthen Boulevard NW (CSAH \#5) northwesterly to the intersection of Alpine Drive and Nowthen Boulevard NW (CSAH \#5), the point of beginning.

Polling Place: Lord of Life Church, 14501 Nowthen Boulevard NW
